iBond Defendant Edition allows for the continuous monitoring of a defendant through the use of their cell phone, complete with geofence capabilities. Through the use of geofences, Progressive Sentencing, Inc. can ensure strict compliance with the Court's orders (domestic violence, cannot depart the Court's jurisdiction, etc.). It is also through the use of geofences that Progressive Sentencing, Inc. monitors if and when a defendant goes to court.

In addition to continuous GPS monitoring, iBond Defendant Edition comes complete with these additional modules:

Conditions of Release: Defendants can easily view their conditions of release.

Check-Ins: iBond Defendant Edition's Check-In module comes complete with facial recognition integration as well as the ability to perform virtual in-person check-ins.

Court Date Reminders: Defendants who are actively being monitored will be able to easily view their next court date and time within the app. In addition, Progressive Sentencing, Inc. uses a text messaging platform to ensure that the phone number is still active.

Most Wanted: In the event that law enforcement would like to gather tips for their most wanted, iBond Defendant Edition allows for the capturing of tips, anonymous and otherwise.

Need An Attorney: For the accused who have the ability to hire private counsel, the app provides them with a list of the top 100 attorneys. For those unable to afford an attorney, they are able to access the contact information for the public defenders office for all counties in which charges are pending. With little modification, this module could allow for the capturing of information routinely filled out on an Affidavit of Indigency, helping to shorten the time between arrest and final disposition.

Identification of Witnesses and Persons of Interest: Through the use of previously reported geolocation data, Progressive Sentencing, Inc. can assist law enforcement in the identification of witnesses and persons of interest.


Resources: From within the app, the accused is able to gain access to resources that will help to address the underlying reason for introduction into the criminal justice system.

From within the mobile compliment, our monitoring staff is able to easily monitor each individual and plot all known addresses, providing greater insight to the reported data.






VIOLATION MANAGEMENT

Our monitoring staff receives notification of a number of violations through Twilio's text messaging platform. Those violations include:

1. Entered Geofence
2. Exited Geofence
3. Low Battery
4. Failure To Report
5. Check-In Picture Does Not Match
6. Change In Location Services
7. Voice Authentication Failure

Our monitoring staff has the capability of reviewing all violations regardless of their physical location and when warranted, can instantly notify the Court.
